The person who will be further selling company products or services through referrals will be called Direct Seller.

COMPENSATION POLICY

Some of us dream of paying our bills and EMI's each month without the burden and worry of whether there will be enough. Others may have visions of helping family members or even helping their communities in meaningful ways. And of course, at one time or another, each of us has dreamt of a restful vacation with those we love, cherishing the happiness that comes when we are stress-free. These are not just dreams; they can become reality with hard work put into the right business. Bizzzwizzz compensation plan can help you achieve these dreams and more.

Company is having two kind of packages, Standard Packages and Customized packages. Compensation policy will be applicable only on standard packages. Further it will be applicable only on first purchase i.e. it will not be applicable on any subsequent purchase or upgrade of existing package by any existing customer. In case of refund, compensation policy will not be applicable on that package and if already paid it will be recovered and if any benefit has been given, it will be withdrawn.

If any subscriber of package is working as Direct Seller with the company, following compensation policy will be applicable:

Diect Referral Commission: It will be paid on the package which will be sold by DS directly where his/her unique ID as a referrer will be used by buyer of package. Commission will be paid @ 5% of sale amount (excluding applicable taxes).

Auto Renewal of Next Year : This benefit will be given on the packages which will be sold by DS directly where his/her unique ID as a referrer will be used by buyer of package. This benefit will be given when DS will refer and generate 5 times sale of his/her standard package amount during the tenure of his package. If DS has upgraded his/her package then he/she need to refer and generate 5 times sale of his/her upgraded package. Once DS fulfills the condition of this benefit his/her package will be renewed for next year with the same services without making any payment.

For the purpose of auto renewal, company will check that what package Direct Seller is having on the expiry date of your package, and if total sale

through your referral code is equals to or more than 5 times of your package amount, your package will be auto renewed within 7 working days from the date of expiry of your package with same benefits for next year

Step commission : This commission will be paid on the matching Business volume (BV) generaged on your both lower legs. Commission will be paid at the rate of Rs. 50 per matching Business Volume (BV). For the purpose of calculation of Business Volume, sale of Rs. 1,000 will be considered as one Business Volume i.e sale amount (excluding applicable taxes) will be divided by 1,000 for calculating Business Volume.

Company may make any change in compensation policy without any prior notice.

Training Policy

Any person who is working as Direct Seller (The person who will be further selling company products or services through referrals) is required to complete the training (s) prescribed by company.

Any person who is working as Direct Seller is required to provide genuine assistance and will ensure that new person is properly and ethically operating and conducting the business. It will give advantage to both the Referrer and their Downline (s).

In case of any volition of these clauses, company has right to stop all you commission payment or available benefits.

ID Card Policy

Any person who is working as Direct Seller should carry his/her national identity card and ID card provided by company and not visit the customer's premises without any prior appointment and/or approval. In case any volition of this clause comes in the notice of company, account will be permanently deactivated and no refund will be granted.
